RULES AND GUIDELINES

We are representatives of Crusaders ATL Sports Club, Inc.; consequently, our behavior is a reflection on the Club. Our aim is to always show our Club to the best advantage, so that we will always attract people to our organization.

Members are required to avoid such behavior that would tend to create adverse criticism of the Club. Our conduct should be such as to merit the confidence and respect of others.

1. Attendance at Meetings:

- 1.1 Members are required to attend meetings regularly.*
- 1.2 Members who are half-hour late without prior knowledge of the Secretary or any other member of the Executive Committee or a reasonable excuse will be considered absent from the meeting.*
- 1.3 Members are allowed a maximum of two (2) absences from meetings in any one calendar year. Failure to adhere will result in suspension from participation in Club activities.*

2. Dues:

- 2.1 Dues shall be \$120.00 per year or \$10.00 per month, payable in advance.*
- 2.2 Dues shall be \$60.00 per year or \$5.00 per month, payable in advance for members 18 years and under.*
- 2.3 Members who are (2) months in arrears shall be deemed non-financial.*

3. Conduct:

- 3.1 Members while representing or in support of Club activities shall conduct themselves in the best behavior.*
- 3.2 Verbal or physical fighting and brawls must be avoided at all times.*

Penalty for the above will be determined by the Disciplinary Committee depending on the severity of the offense.

- 3.3 Members shall not argue or dispute umpire's decisions during a game.*

Penalty for the above will be suspension for 2 games for the first offense, suspension for the rest of the season for the 2nd offense.

If after suspension conduct has not improved the member(s) will be terminated from the Club.

3.4 *Members are responsible for the conduct of our spectators supporting the Club.*

4. *Sporting Activities:*

4.1 *The Coach and/or Assistant Coach are in charge of all practice sessions and games. Decisions made by the Coach and/or Assistant Coach are final.*

4.1a *Team selection shall be done by the Coach and/or Assistant Coach.*

4.1b *Captains, Vice Captains and Team Managers are:*

- (i) expected to be at each practice session;*
- (ii) responsible for communicating with team members regularly;*
- (iii) responsible to ensure that their team take out and return the netball equipment at practice sessions and games; and*
- (iv) responsible for their team's uniform maintenance.*

4.1c *In order to present a uniformed and team environment - Training attire shall be white t-shirt and black bottoms.*

4.2 *Practice sessions are held twice a week (days to be determined each year) at 6:00 p.m. from March through November.*

4.3 *Members are required to attend at least one (1) practice session per week to be eligible to represent the Club; full participation is required by all members in attendance.**

4.4 *Team shall consist of no less than ten (10) members when the club is committing to participate at Rallies and Tournaments.*

4.5 *Members are prohibited from competing against the club in any league that the club is registered to play.*

(Penalty for 4.5 will be suspension from all club activities for the year)

4.6 *Members may not play against the club in rallies without first obtaining approval from the majority of the team players scheduled to play that day.*

(Penalty for 4.6 will be suspension from all club activities for year)

4.7 *Members shall be responsible for the Club's property for the time they are in their possession.*

Penalty for 4.7 shall be reimbursement of the cost to replace such item(s); failure to reimburse could lead to suspension from the Club.

4.8 *Members representing the Club shall wear the complete uniform at all times.*

Penalty for 4.8 shall be a \$10.00 fine, which shall be paid prior to the next scheduled game. Failure to do so will result in no play until the fine is paid.

4.9 *Members selected to represent the Club shall be present half-hour before scheduled time of the game**

Penalty for the first offense will be no start that day and a fine to be determined by the Disciplinary Committee; second offense, no play that day and a fine to be determined by the Disciplinary Committee.

If the offense continues, disciplinary measures could lead to suspension from the Club.
